In *People v Lockridge*, 498 Mich 358 (2015), the Michigan Supreme Court concluded that the Michigan sentencing guidelines create a mandatory minimum sentence range that violates the rule of *Apprendi v New Jersey*, 530 US 466 (2000), and *Alleyne v United States*, 133 S Ct 2151 (2013), and thus violates the

Sixth and Fourteenth Amendments, because the sentencing scheme uses judicial fact-finding in the scoring of the offense variables.
