Key Provisions- Food Handler: Beginning July 1, 2014 all food handlers employed by restaurants will be required to receive or obtain ANSI accredited training in basic safe food handling principles within 30 days of employment and every 3 years thereafter.

### **California Food Handler Training**

A food handler is someone who handles, prepares, serves, sells, or gives away food for human consumption. Is this food handler training and test approved for my area? This program that includes a training and test is approved for use throughout San Bernardino County, California.

### **Food Handlers Card California | Food Safety Courses Online**

A food handler card is valid for three years from the date of issuance. Food handlers must retake and pass the food handler card class every three years to maintain a valid California food handler card. Note: Environmental Health & Safety does not offer food handler card classes.

### **California Food Handlers Card | StateFoodSafety**

A food handler is defined by law as a person who works in a food facility and performs any duties that involve the preparation, storage or service of food in a food facility. Riverside and San Bernardino counties have existing local food handler requirements and are not affected by the state law.

California Food Handler Card Law implementation and to notify regulated facilities accordingly. All cards issued in compliance with the existing requirements of the California Food Handler Card Law or the recommended revised requirements, once adopted, shall be valid for 3 years from date of issuance.

California Food Handler Regulations Our course allows YOU to take personal responsibility for food safety, as well as being able to demonstrate basic principles of good practice needed to keep food areas, kitchens, front of house and yourself clean and safe.

### **California Food Handler Card Online Training**

A CA Food Handler Card is required by law. Employees who handle food must have a California Food Handler card on file with their employer within 30 days of hire. To obtain a card, you must complete the training and pass the exam with a 75 percent or higher.

### **CALIFORNIA FOOD HANDLER CARD LAW GUIDELINES**

The California Food Handler Card law is designed to ensure that restaurant employees receive a reasonable level of training in food safety practices to reduce the potential for foodborne illness. Food handlers must have a California Food Handler Card 30 days from the date of hire.
