Your EEA family member's valid passport or national identity card. You may also provide a certified copy if you cannot provide the original document. Evidence of your relationship to your EEA family member. This would be documents such as a marriage certificate, civil partnership certificate, proof that you have lived together for 2 years (if you are unmarried) or birth certificate.
