# **State Labor Laws | U.S. Department of Labor**

The law does not designate a minimum amount of time the information must be kept. Georgia Code 34-4-5. Federal law requires every employer covered by the Fair Labor Standards Act (FLSA) to keep certain records for each covered, nonexempt worker, for at least 3 years. For more information, visit FLSA.
