In his capacity as commander in chief, Lincoln declared martial law in all states and ordered the suspension of the constitutionally protected right to writs of habeas corpus in the state of Maryland and parts of the Midwestern states.

However, President Abraham Lincoln decided to suspend the right of habeas corpus, and the general in command of Fort McHenry refused to turn Merryman over to the authorities.

Soon after Abraham Lincoln was elected to the presidency in November 1860, seven southern states seceded from the Union. In March 1861, after he was inaugurated as the 16th President of the United States, four more followed. The secessionists claimed that according to the Constitution every state had the right to leave the Union.

Lincoln's call for 75,000 volunteers on April 15th, 1861 as a response to the firing on Fort Sumter as of 12 April, 1861. What it did to the northern tier of slave states (Virginia, North Carolina, Tennessee and Arkansas) was trigger their secession. Thus the war began.

Along with declaring martial law, President Abraham Lincoln ordered the suspension of the constitutionally protected right to writs of habeas corpus in 1861, shortly after the start of the American Civil War. At the time, the suspension applied only in Maryland and parts of the Midwestern states.
