For additional locality pay areas to be established in January 2014, the Council selected 12 areas with the largest pay disparities between GS and non-Federal pay averaging more than 10 points above that for the "Rest of U.S." locality pay area over a 4-year period. These 12 areas are: Albany-Schenectady-Amsterdam, NY Combined Statistical Area

The President's Pay Agent accepted the Council's recommendation and directed the U.S. Office of Personnel Management (OPM) to define locality pay areas on the basis of OMB's definitions of metropolitan areas. Since then, the Council and Pay Agent have continued to use OMB-defined metropolitan areas as the basis for locality pay area definitions.

2014 Locality Pay Area Definitions. All locality pay areas and definitions for 2014 are the same as those in effect in 2013. Most of the place names listed below are counties. The Federal Information Processing Standards (FIPS) geographic codes consist of a two-digit State and three-digit county identifier.

Rest of U.S. Locality Area - General Schedule Localities . The "Rest of United States" GS locality is the default locality area that applies to GS employees in any city that does not fall within another specified GS Locality. The 2020 Locality Pay Adjustment for the Rest of U.S. is 15.95%, which means that GS employees nationwide are paid at least 15.95% more than the GS Base Pay Table.
